This Privacy Notice outlines how we collect, use, disclose, and protect your personal data in connection with your interaction with PIKOM, including but not limited to event participation, membership, communication, and digital services.

#### 1. Collection of Personal Data

We may collect personal data from you through various means, including when you:

- Register for or attend PIKOM events (e.g., webinars, conferences, exhibitions)
